PARTICIPANTS WHO TERMINATE COVERAGE MID-PLAN YEAR FOR EITHER AN FSA OR HRA WILL HAVE 60 DAYS AFTER TERMINATION DATE OR COBRA PAID-THRU DATE TO SUBMIT CLAIMS.
